

# **ARPA & SLFRF Overview**

## Which Laws apply?

## Federal and State Laws

**ARPA** 

**American Rescue Plan Act.** Signed into law on March 11, 2021, for the purpose of expediting the country's recovery from the economic and health effects of the COVID-19 pandemic.

**SLFRF** 

**Passed as part of ARPA, State and Local Fiscal Recovery Funds (SLFRF)** provide state, local, and Tribal governments with funding to respond to the pandemic and its economic effects including necessary investments in broadband infrastructure to address challenges with access, affordability, and reliability.


ARPA Broadband
Account

Established by the SC General Assembly House Bill 4408 for the administration of grant programs to expand broadband infrastructure to households, businesses, and communities in the State that are unserved or underserved by broadband services.

SC ARPA Broadband Grant Program

Established by ORS for the purpose of expanding broadband infrastructure in South Carolina.





# How do ISPs know which requirements apply?

Use of SLFRF Funds require compliance with all governing Federal rules

ORS

- Determines eligible investments and awards projects to contractors
- Reviews projects for compliance and processes payments
- Submits required reporting (quarterly and annually)
- Monitors contractors for compliance



- Adhere to federal / ORS contracting requirements
- Impose required conditions to subcontractors
- Submit required reporting
- Maintain documentation for retention period

# What are the reporting requirements?

## US Treasury requires ORS to report:

- Quarterly
  - o Project Description, Timing, Location
  - For Broadband Projects
    - Additional Location, Technology Type, and Speed Test requirements
  - Status of Project completeness (Not started, in progress, completed)
  - All expenditures
- Annually
  - Use of Funds
  - Project Completeness reported as a Project Inventory
  - Narrative sections regarding project impacts
    - Community benefits, Justice40, Civil Rights compliance,
       Community Engagement, and Labor Practices

Because of these federal requirements, ISPs will also be required to provide detailed project information on a recurring basis.

# Reporting

## Contractors are responsible for meeting reporting requirements

- Reporting requirements are determined by US Treasury and conveyed to Contractors in executed contracts
- US Treasury reporting guidance can be found in the Project and Expenditure Report User Guide & the Compliance and Reporting Guidance documents

- Further requirements are determined by South Carolina and Office of Regulatory Staff
- Broadband projects have extensive reporting requirements, one example:

# ORS will report pre-investment information, including:

- 1. Internet availability
- 2. Speed tests before investment
- 3. Locations for investments

# ISP will provide investment information, including:

- 1. Speed Tests after investment
- 2. Speed tiers offered after deployment
- 3. Location by location reporting on technology and speeds



# What are the specific Broadband reporting metrics?

Confirm that the project is designed to, upon completion, reliably meet or exceed symmetrical 100 Mbps download and upload speeds.	If the project is not designed to reliably meet or exceed symmetrical 100 Mbps download and upload speeds, explain why not
	Confirm that the project is designed to, upon completion, meet or exceed 100 Mbps download speed and between at least 20 Mbps and 100 Mbps upload speed, and be scalable to a minimum of 100 Mbps download speed and 100 Mbps upload speed
Total miles of fiber deployed (Planned/Actual)	
Total number of funded locations served (Planned/Actual)	Total number of funded locations served, broken out by speeds:
	Total number of funded locations served, broken out by type (Planned/Actual)
Speed tiers offered, corresponding non-promotional prices, including associated fees, and data allowance for each speed tier of broadband service (required starting October 2022)	
Location information:	Latitude/longitude at the structure where service will be installed

# How will ISPs report these metrics?

Executed contracts between ORS and ISPs will include the information and templates for collecting required reports from ISPs. Reports will include, but are not limited to:

- Project start-up reporting
  - Project description
  - o Planned investment criteria
- Quarterly reporting (once construction starts):
  - Quarterly Financial and Construction Progress report
  - Labor and wage tracking
- Completion of project reporting:
  - Final expenditure information
  - Final labor and wage information
  - Actual investment criteria
- · Ad hoc reporting, as needed

# Federal Contracting Rules: Davis-Bacon Act

## **Does Davis-Bacon Act apply to my Project?**

 Davis-Bacon Act requirements (prevailing wage rates and reporting) do not apply to projects funded solely with funds from the SLFRF program.

# Contracts \$10M and greater: Labor reporting

### Do any Wage and Labor reporting requirements apply?

- Yes
- If total contract awarded to ISP is >\$10M, documentation of wages and labor is required.
  - These requirements can be met with certifications by the ISPs that the project is in compliance with the Davis-Bacon Act
  - Otherwise, ISPs provide project employment report.
- Wage and employee data must be collected and reported for contractor and all subcontractors

# Contracts Less than \$10M: Labor reporting

## Do any Wage and Labor reporting requirements apply?

- No
- For any contract in an amount less than \$10M, there are no wage nor labor reporting requirements

# **Project Example #1**

\$9.5M Total Project cost with a contract for \$7M in SLFRF funds

Wage and Labor Information is <u>NOT</u> required



# **Project Example #2**

\$24M Total Project cost with a contract for \$9M in SLFRF funds

Wage and Labor Information is **NOT** required



# **Project Example #3**

## \$18M Total Project cost with a contract for \$11M in SLFRF funds

### Provide a project employment report detailing:

The number of employees of contractors and sub-contractors working on the project

The number of employees on the project hired directly and hired through a third party

The wages and benefits of workers on the project by classification

Whether those wages are at rates less than those prevailing.

Recipients must maintain sufficient records to substantiate. (Included as Exhibit N of signed contracts)

- 1. WH-347 Form
- 2. Statement of Compliance
- 3. Submitted Weekly

## Federal Contracting Rules: BABA & NEPA

Is either provision triggered?

**Build America, Buy America** 

ORS ISP Infrastructure contracts are funded solely with SLFRF and, therefore, are **not subject to BABA requirements.** 

NEPA review is not required, but contractors must comply with all environmental and permitting laws and regulations.

**National Environmental Policy Act** 



# **Federal Contracting Rules: Non-Discrimination**

All Contractors are required to meet legal requirements relating to nondiscrimination and nondiscriminatory use of Federal funds. Contractors must not deny benefits or services, or otherwise discriminate on the basis of race, color, national origin (including limited English proficiency), disability, age, or sex (including sexual orientation and gender identity). Statutes and regulations prohibiting discrimination applicable to this award include, without limitation, the following:

Title VI of the Civil Rights Act of 1964

Fair Housing Act, Title VIII of the Civil Rights Act of 1964

Section 504 of the Rehabilitation Act of 1973

Age Discrimination Act of 1975

Title II of the Americans with Disabilities Act of 1990

(42 U.S.C.  $\S\S$  2000d et seq.) and Treasury's implementing regulations at 31 C.F.R. Part 22, which prohibit discrimination on the basis of race, color, or national origin

(42 U.S.C. §§ 3601et seq.), which prohibits discrimination in housing on the basis of race, color, religion, national origin, sex, familial status, or disability;

as amended (29 U.S.C. § 794), which prohibits discrimination on the basis of disability under any program or activity receiving federal financial assistance;

as amended (42 U.S.C. §§ 6101 et seq.), and Treasury's implementing regulations at 31 C.F.R. Part 23, which prohibit discrimination on the basis of age in programs or activities receiving federal financial assistance;

as amended (42 U.S.C. §§ 12101 et seq.), which prohibits discrimination on the basis of disability under programs, activities, and services provided or made available by ORS and local governments or instrumentalities or agencies thereto.



Comply with all Federal, State and Local Environmental laws

Obtain all required Federal, State and Local permits





# Debarment & Contractor in Good Standing



# **Debarment & Contractor in good standing**

## These requirements flow down from ORS to ISPs to Subcontractors

### ISP (Contractor)

- Required to obtain a **Unique Entity Identifier (UEI)** number through **SAM.gov registration**.
- Required to include a term or condition in all lower tier covered transactions that the award is subject to 2 CFR Part 180 and Treasury's implementing regulation at 31 CFR Part 19.
  - Guidelines to Contractors on government wide debarment and suspension.
- Only award subcontracts to entities that are in good standing and have not been debarred.

#### Sub-Contractor

- Must be in and stay in good standing and have not been debarred.
- How do I know if my subcontractor is in good standing and has not been debarred?


# Affordable Connectivity Program



# **Affordable Connectivity Program**

## Applicable to all projects that service households

The service provider for the project will either **be participants in the Federal Communications Commission** (FCC) Affordable Connectivity Program (ACP) or otherwise provide evidence that affordable access commensurate with those provided under the ACP to low-income consumers in the proposed service area.



# Bonding Requirements



# **Bonding Requirements**

ORS follows their standard bonding policy and requirements

### **ORS Bonding Policy**

ORS will issue Notice to Proceed (NTP) contingent on the ISP acquiring a bond and submitting proof of bond to ORS.




