Pre-Qualification Attachment Checklist

Purpose: This document offers a checklist for completing the corresponding Pre-Qualification Application submission process for the South Carolina BEAD Program. All prospective subgrantees must submit a Pre-Qualification Application and associated attachments to be eligible to apply for funding through the SC BEAD program.

The due date for the Pre-Qualification Application and Attachment Submission is **December 13th**, 2024.

BEAD Pre-Qualification Attachments Checklist

The checklist below is meant to guide Applicants as they complete and submit information during the Pre-Qualification phase of the South Carolina BEAD grant program. This checklist identifies the required attachments needed in order for the South Carolina Broadband Office to effectively assess gating criteria for all prospective applicants.

This document does not need to be included as part of the required submission for the Pre-Qualification application and associated attachments, its intent is to assist Applicants in providing a complete submission to the South Carolina Broadband Office (SCBBO). The following documentation listed below is required for submission and must be completed in its entirety as part of the BEAD Pre-Qualification phase. Incomplete submissions may be rejected by the SCBBO.

☐ For Applicants that operate electric transmission or distribution services provide qualified operating or financial reports that it has filed with the relevant financial institution for the relevant time period along with a certification that the submission is a true and accurate copy of the reports that were provided to the relevant financial institution.

☐ Organizational chart(s) detailing all parent companies, subsidiaries, and affiliates.
