  - Removed \$438 million in contingency and added \$174 million.
- 4. Docket No. 2012-90-E filed on February 29, 2012.
  - Withdrawn two and a half months later on May 8, 2012.
- 5. Docket No. 2012-203-E filed on May 15, 2012. [Order No. 12-884 dated November 15, 2012.]
  - Move Unit 2: April 1, 2016 to March 15, 2017.
  - Accelerate Unit 3: Jan. 1, 2019 to May 15, 2018.
  - \$283 million in additional capital costs.

The \$698 million is composed of approximately \$453 million in Engineering, Procurement and Construction Contract ("EPC Contract") Costs and \$245 million in Owner's Costs. Of the \$698 million request, \$539 million attributed to delay and disputed costs \$325 million (which is net of \$86 million in liquidated damages) in EPC Contract Costs and \$214 million in owner's costs.

  - Move Unit 2: June 19, 2019 to August 31, 2019.
  - Move Unit 3: June 16, 2020 to August 31, 2020.
  - ORS negotiated Settlement Agreement wherein SCE&G would elect the fixed price option in its EPC Contract with Westinghouse, and would in turn agree to fix the price for EPC costs to ratepayers.
  - Settlement Agreement allowed \$831.3 m out of the \$852 m requested.
  - 98% of the EPC Contract Costs become fixed as a result of the Settlement Agreement.
  - Modification requests are not permitted until at least Jan. 28, 2019. If substantial completion date for Unit 2 moves, the moratorium for modification requests moves (except for a change in law) an equal amount.
  - Settlement Agreement reduces ROE to 10.25% from 10.5%
