



ORS VEHICLE REGISTRATION FORM

This is a vehicle registration form. As of May 23, 2022, S.C. Code of Laws Section 58-23-560 states: A holder of a certificate A, B, or C must annually before January first of each year pay to the Office of Regulatory Staff a fee of fifty dollars per vehicle. A failure to renew or register new vehicles could result in a fine or revocation of operating Certificates. All registration payments are non-refundable. The deadline to renew vehicle registration is **December 31, 2024**. You are renewing your registration for:
