**HTC Marion Priority 1**

**Service Requests**

HTC has received 591 requests for service in this project area. This illustrates the existing need for services and the readiness of residents in this area to subscribe to service. A map illustrating a distribution of those requests is attached.

**Student Households**

HTC has identified 274 student households in our project area and is committed to working with Marion County School District to support their student and teachers' online learning needs, including through community education program. A map of these student locations is attached.

**Broadband Pricing Tiers**

HTC is participating in the FCC's Emergency Broadband Benefit Program, and will offer it to members in its project area for as long as funding is available. All HTC internet tiers and bundles are eligible for this discount; eligible households will be able to receive 300 Mbps / 300 Mbps of internet through our standalone Tier 1 package for less than \$10 per month through the EBB program. HTC is advocating for additional funding for the EBB program to become a permanent program.

**The Cooperative Advantage**

As a cooperative, the core of our mission is the commitment to improve the lives of the communities we serve through connectivity. Because HTC is a not-for-profit entity, our decisions are driven by what benefits the Cooperative and our community, not by shareholders. Our profits are reinvested into our network and allocated back to our members in the form of capital credits. All the residents and businesses that we serve with this grant project will enjoy the full benefits of an HTC membership.

HTC's track record in Horry County and our recent success in the SCBIP project in Marion and Georgetown Counties demonstrate that the Cooperative is well positioned to help the state continue to bridge the digital divide in the Pee Dee region as quickly, and efficiently, as possible. We completed our SCBIP projects ahead of schedule, and even committed to additional expansion with only one month remaining before the CARES Act funding deadline. HTC would like to keep the momentum going and continue to expand broadband access in Marion and Georgetown, and we believe allocating these funds to successful BIP recipients that can efficiently extend off existing networks in unserved and underserved areas would be the most effective use of these funds.

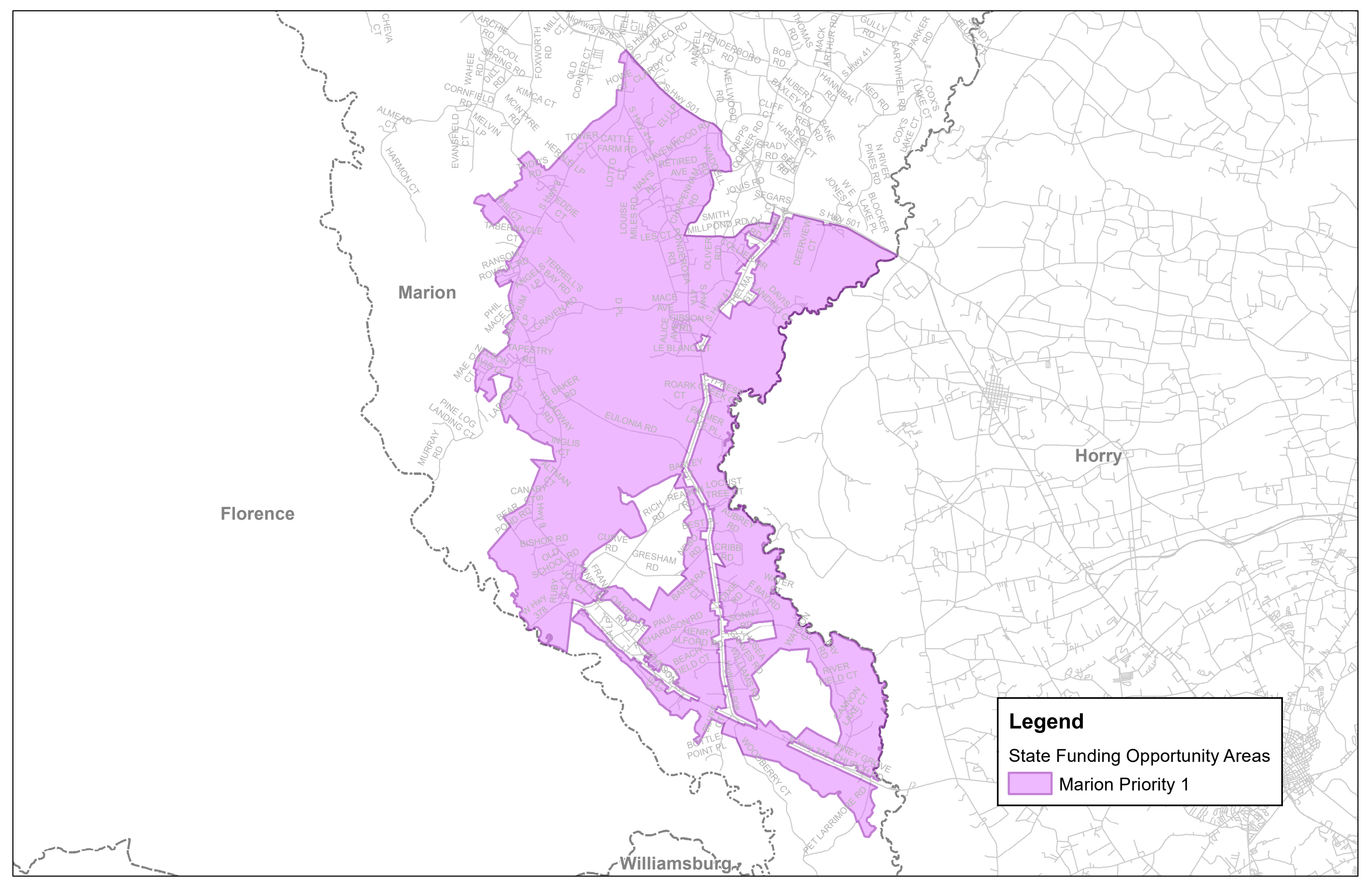

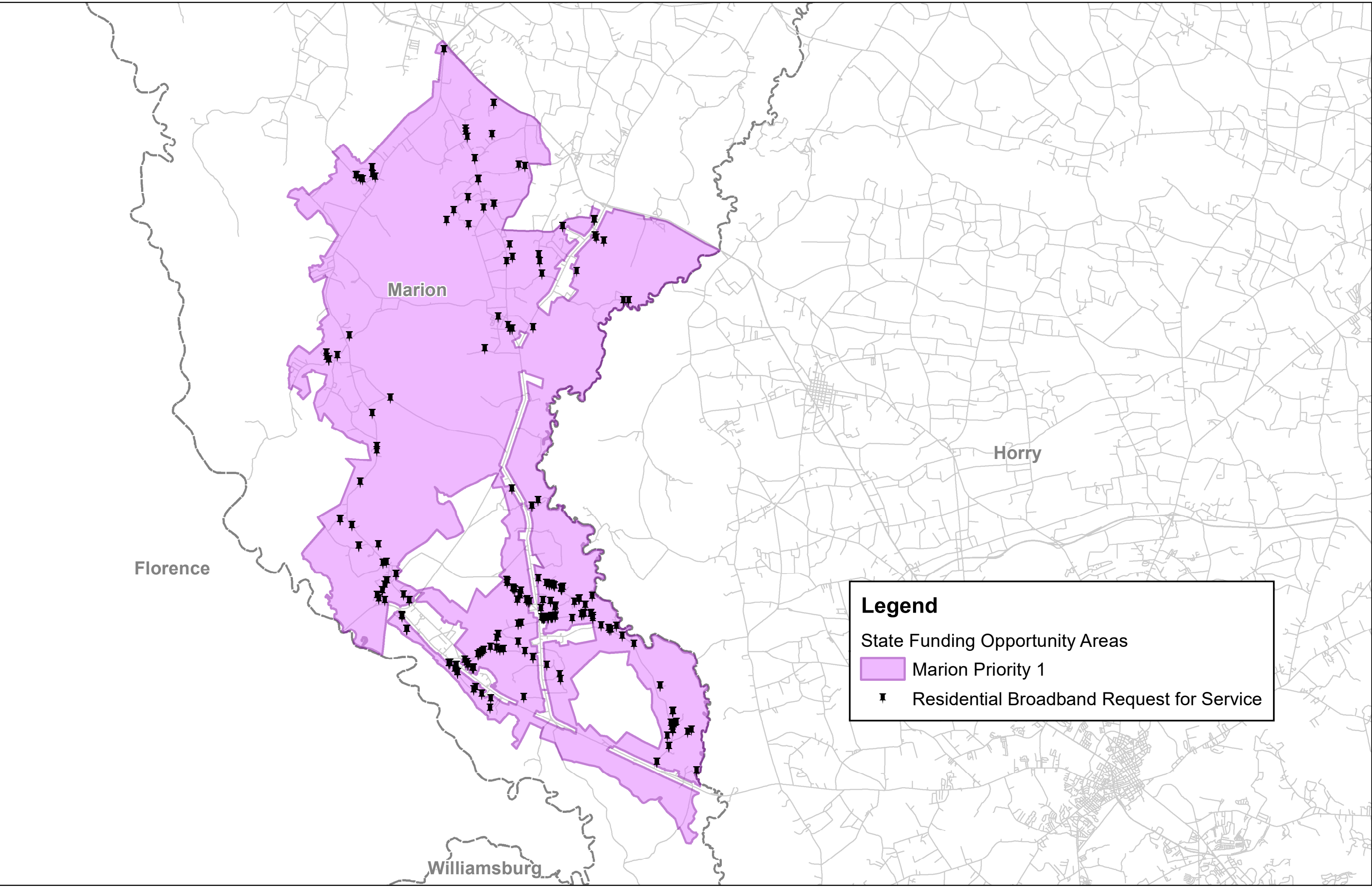

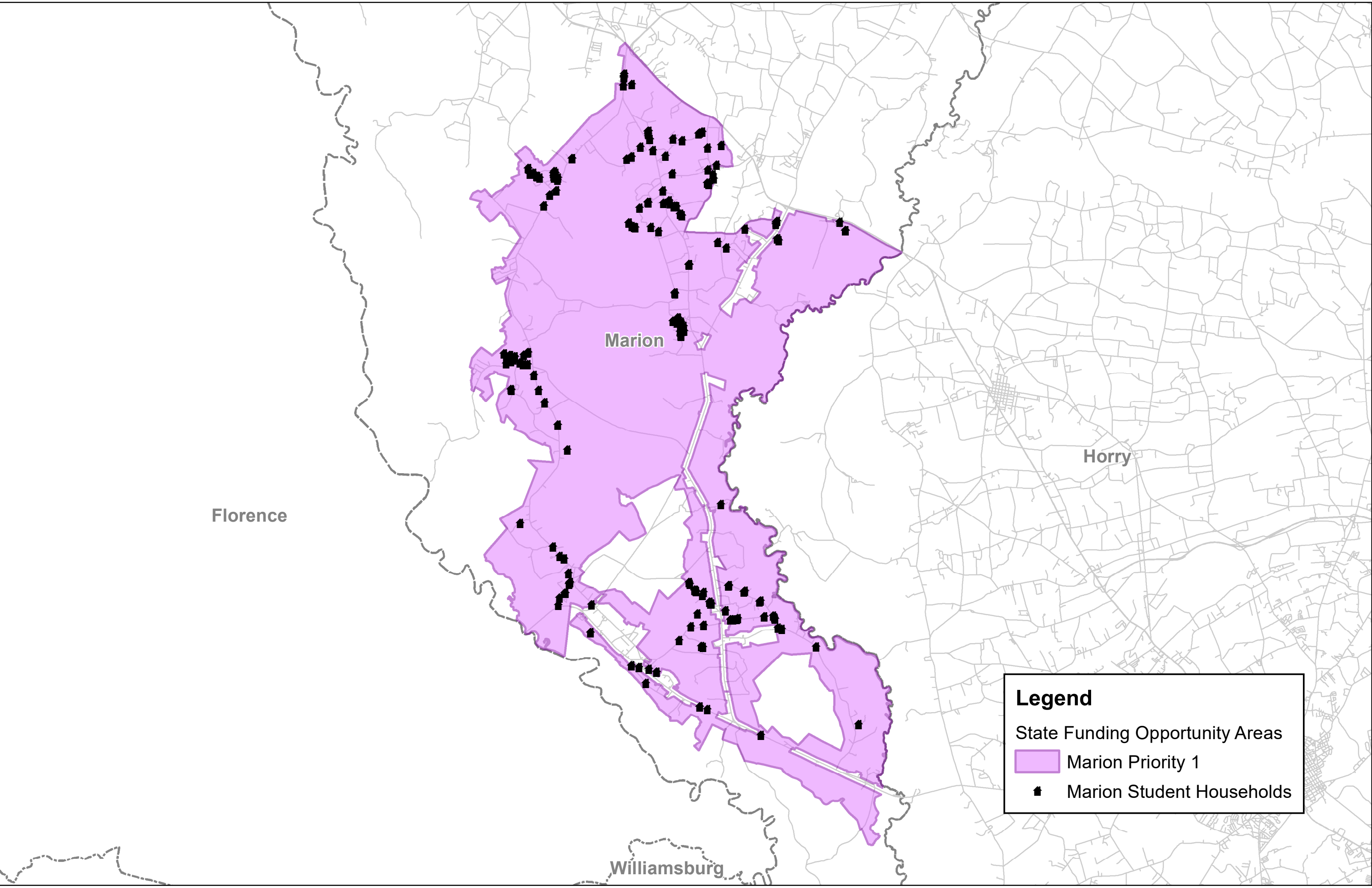
