This is a response to your correspondence dated June 18, 2023, in which you requested information pursuant to the Freedom of Information Act (FOIA) and the Federal Energy Regulatory Commission's (Commission) FOIA regulations. ${ }^{1}$ You have requested the following:
"Any and all documentation and correspondence related to [EPA's proposed rule published in Federal Register, Volume 88, No. 99] consultation between the EPA and the Federal Energy Regulatory Commission." ${ }^{2}$

A search of the Commission's non-public files has identified 29 email communications and other documents that may be responsive to your request. As explained below, six of these documents are released with redactions taken pursuant to FOIA Exemptions $5^{3}$ and $6^{4}$, and 23 documents are withheld in full pursuant to Exemption 5.

## FOIA Exemption 5

FOIA Exemption 5 protects from disclosure certain intra-agency and inter-agency documents, and incorporates various privileges, including the deliberative process privilege, which is at issue here. Courts have consistently held that three policy purposes constitute the basis for the FOIA Exemption 5 deliberative process privilege: (1) to encourage open, frank discussions on matters of proposed policy between subordinates and superiors; (2) to protect against premature disclosure of proposed policies before they are finally adopted; and (3) to protect against public confusion that might result from disclosure of reasons and rationales that were not in fact ultimately the grounds for an agency's action. See Russell v. Dep't of the Air Force, 682 F.2d 1045, 1048 (D.C. Cir. 1982); see also EPA v. Mink, 410 U.S. 73, 87 (1972) (recognizing that "[i]t would be impossible to have any frank discussions of legal or policy matters in writing if all such writings were to be subjected to public scrutiny.").

Here, the 23 withheld e-mails and documents, and the redacted materials from emails, are comprised of inter-agency work product from and to the Office of Management and Budget ( OMB ) and intra-agency communications and draft documents, all of which contain the type of deliberative information Exemption 5 was created to protect. Specifically, the documents were prepared in anticipation of the EPA's proposed rulemaking, which has not yet been finalized. Release of the pre-decisional material would create the foreseeable harm of discouraging Executive branch officials from consulting with one another during the decision-making process. See Russell, 682 F.2d at 1048.

Moreover, because the factual information contained within the documents are so inextricably intertwined with the deliberative material, withholding the documents in their entirety is appropriate. See STS Energy Partners LP v. FERC, 82 F.Supp.3d 323, 331 (D.D.C. Mar. 4, 2015) (quoting Mead Data Ctr., Inc. v. U.S. Dep't of the Air Force, 566 F.2d 242, 261 (D.C. Cir. 1977)).

## FOIA Exemption 6

FOIA Exemption 6 protects personnel or similar files that if disclosed would constitute a clearly unwarranted invasion of privacy, including names, phone numbers, and personal information of private citizens. Here, the redacted portions of the documents concern names of non-senior staff, telephone numbers or other personal contact information, and teleconference numbers and access passcodes. This information is redacted to prevent the foreseeable harm that disclosure could invite unwanted intrusions or result in an unwarranted invasion of personal privacy.

The six documents are enclosed. As provided by the FOIA and 18 C.F.R. § $388.110(\mathrm{a})(1)$ of the Commission's regulations, any appeal from this determination must be filed within 90 days of the date of this letter. The appeal must be in writing, addressed
to Matthew Christiansen, General Counsel, and emailed to FOIAAPPEALS@ferc.gov. If you do not have access to email, a hard copy may also be sent via traditional mail to Matthew Christiansen, General Counsel, with a copy to Charles A. Beamon, Associate General Counsel, General and Administrative Law, at Federal Energy Regulatory Commission, 888 First Street, NE, Washington, DC 20426.

You also have the right to seek dispute resolution services from the FOIA Public Liaison of the agency or the Office of Government Information Services (OGIS). Using OGIS services does not affect your right to pursue your appeal.
